**When describing journal articles,** indicate the DOI identifier.

**When describing books,** do not mention such subheadings as monograph, textbook, coursebook.

**Check the correctness of each source description** on the Internet.

**Do not "blindly" use transliterators** for publications translated into Ukrainian or Russian, but check the correctness of their description in English on the Internet, especially the authors' names.

**The author's name** is the name of a natural or legal (collective) person.

There must be a space **between the initials in the author's name**.

**If only the author's last name is indicated** (Aristotle, Plato), then do not put a full stop after it (for example, Aristotle (1998)).

**The title of the article in the journal or part of the book** should be written in the usual font, and the sources described in Cyrillic should be transliterated and written in English in square brackets (square brackets are also in the usual font).

**The title of the journal and the book** should be written in italics, and the sources described in Cyrillic should be transliterated and written in English in square brackets (square brackets are also in italics). The issue volume and journal issue are also highlighted in italics.

**If in the original the source is not described in Cyrillic, and English** (for example, French), then it is not necessary to transliterate, only in square brackets to write in English, and at the end to specify what language it is (for example, (in Fr.)).

**The name of the source language from which the translation is made** is indicated in abbreviated form, following the accepted rules of abbreviation (e. g., Trans. In Eng .; Trans. In Fr .;).

**The names of cities should not be shortened** but submitted under the international description (e. g., Kyiv; Moscow; St. Petersburg; New York; London).

### **Publisher names:**

- 1) for sources written in Latin - to submit in the original language;
- 2) for sources written in Cyrillic - transliterate.
